ALL MATERIALS AND SUPPLIES ARE PROVIDED AND SESSIONS ARE FREE OF CHARGE TO PARTICIPANTS. EACH CLASS/WORKSHOP IS OVERSEEN BY A LICENSED MENTAL HEALTH PROFESSIONAL, AS THERAPEUTIC OPPORTUNITIES OCCUR. THE EXECUTIVE AND PROGRAM DIRECTORS PROVIDE OUTREACH AND EDUCATIONAL PRESENTATIONS TO COMMUNITY GROUPS.
